2. Minutes of the last AGM

3. Chairs Report

The Slide The slide which occupies the village hall garden (which is now over 30 years old) is causing problems with the village hall insurance, as it was considered a medium risk in last years ROSPA inspection. David explained if our insurance company wasn't able to cover the slide it would have to be condemned. It was generally felt this would be a real lose to the village. This years Rospa inspection is due in June. David confirmed he would forward the report to the insurance company. if they refused to insure the slide we would be forced to remove it. It was, however, expressed that if this were the outcome a replacement needed to be seriously considered.
